Under Article 23 of the Law on Public Procurement (Official Gazette 24/19) ESM Prodazba DOOEL Skopje announces:

## PUBLIC CALL No. 01-2022 for collecting bids for purchase of natural gas

## 1. GENERAL PROVISIONS

- 1.1 The contracting authority according to public call No. 01-2022 is ESM Prodazba DOOEL Skopje, with headquarters at 11 Oktomvri Street No. 9, Skopje.
- 1.2 The subject of the purchase is: natural gas.
- 1.3 The announcement is public with the right to participate to all domestic and foreign legal and natural persons registered for this type of activity.

## 2. CONTENT OF THE BID

2.1 The bid should contain the total amount of natural gas that the bidder has provided at the main measuring station (GMS) Zhidilovo, for the period 01.01.2023 to 04.30.2023, stated in measurement units of Kwh and/or Nm³.
If the bid is submitted only in measurement units Nm³, the natural gas must be of the following quality:

-	Methane (CH4)min. 85%
-	Ethan (C2H6)max. 7%
-	Propane (C3H8), Bhutan (C4H10) and heavier Hydrocarbons
-	Inert gases Nitrogen (N2 + CO2)max. 7%
-	Carbon dioxide (CO2)max. 2,5%
	Oxygen (O2)max. 0,001%
-	Total Sulphurmax. 30 (mg/m3)
-	Hydrogen sulphide (H2S)max. 5 (mg/m3)
-	(RHS)max. 6 (mg/m3)
	Upper calorific value Hg, kWh/m3 – min.10,28 / max.12,75
	Lower calorific value Hd, kWh/m3 – min.9,25 / max. 11,47

\*The values refer to a natural gas volume of 1 Nm³ at a pressure of 1.01325 bar and a temperature of 20°C.

If the bid is submitted in kWh, a confirmation that the natural gas is of quality within the defined limits must also be submitted.

2.2 The bid should contain a unit price per measurement unit in which the offer is submitted.



- 2.3 The bid should contain the name, address and registered office of the offeror.
- 2.4 Technical characteristics of natural gas (quality certificate).
- 2.5 The country of origin of the natural gas.
- 2.6 Terms of payment.
- 2.7 A statement from the bidder's responsible person to confirm the ability to provide the specified quantities of natural gas for the period for which the offer is made.
- 2.8 A copy of the Agreement, Statement, Written Approval or other appropriate document that can be used to confirm that the bidder have permission from the natural gas producer to dispose of the quantities and are able to trade with them.
- 2.9 Method of security guarantee, if an advance payment is required.
- 2.10 Bidders shall bear all costs associated with the preparation and submission of their bids, and the Contracting Authority shall in no event be responsible or liable for these costs.
