



Under Article 23 of the Law on Public Procurement (Official Gazette 24/19) ESM Prodazba DOOEL Skopje announces:

PUBLIC CALL No. 05-2023 for collecting bids for purchase of natural gas

1. GENERAL PROVISIONS

- 1.1 The contracting authority according to public call No. 05-2023 is ESM Prodazba DOOEL Skopje, with headquarters at 11 Oktomvri Street No. 9, Skopje.
- 1.2 The subject of the purchase is: natural gas in the amount of 1200 MWh minimum daily quantity up to 4950 MWh maximum daily quantity, with a flexible start date on one of the days between 01.10.2023 and 15.10.2023, end date 31.10.2023 / gas-day, at the delivery point of the main measuring station (GMS) Zhidilovo, and the possibility of one-day deliveries in the period 01.10.2023 14.10.2023, with the same minimum daily quantities and maximum daily quantities.
- 1.3 The announcement is public with the right to participate to all domestic and foreign legal entities registered for this type of activity.
- 1.4 Period of accepting the bids following the public call No. 05-2023 is from 09:30 AM-until 10:00 AM o'clock on 22.09.2023 CET to an e-mail: ponudi@esm-prodazba.mk

2. CONTENT OF THE BID

- 2.1 The bid should contain:
- 2.1.1 Technical characteristics:

The natural gas must be of the following quality:

Chemical composition, mol %

Methane (C1)

minimum 75

Nitrogen (N2)

maximum 6

Carbon dioxide (CO2)

maximum 3

Gross (upper) caloric value

Maximum 13.67 kWh/m3

Minimum 10.17 kWh/m3

Wobbe Index

Maximum 16.33 kWh/m3



Minimum 13.07 kWh/m3

Water dew point

Not higher than minus 8 degrees Celsius at a pressure of 39.2barg

Natural gas temperature

from +0° C to +50°C

The above reference conditions for temperature, pressure and humidity, to be used for natural gas measurements and calculations, are 273.15 K (=0 °C) and 101.325 kPa (=1.01325 bar (absolute)) for true dry gas.

- 2.1.2 The country of origin of the natural gas
- 2.1.3 Total quantity of natural gas that the bidder has secured at the main measuring station Zhidilovo, for the period 01.10.2023 to 31.10.2023 / gas-day, expressed in units of measurement MWh.
- 2.1.4 Unit price in EUR and measurement unit MWh (EUR / MWh). The calculation of the denar equivalent of the price of the offer will be done according to the average exchange rate of the NBRNM on the date of submission of the offers. The price is fixed for the entire delivery period.
- 2.1.5 Terms of payment. (in case of advance payment, the monthly quantity of the lower rank is paid 1200 MWh per day).
- 2.1.6 The subject of invoicing in the final invoice will be the confirmed daily nominations after the end of the month. The bid should contain the name, address and registered office of the bidder.
- 2.1.7 Method of security if advance payment is required (bank guarantee or corporate guarantee).
- 2.1.8 A statement from the bidder's responsible person that the bidder is able to provide the specified quantities of natural gas for the period for which the bid is submitted.
- 2.1.9 Bidder's name, address and registered office.
- 2.1.10 Bidders shall bear all costs associated with the preparation and submission of their bid, and the Contracting Authority shall in no event be responsible or liable for these costs.
- 2.1.11 ESM Prodazba DOOEL Skopje reserves the right to reject any offer, to accept or not to accept the quantities of natural gas submitted by the legal entity or to cancel the procurement procedure.

3. METHOD OF SUBMITTING THE BIDS

Bids are to be submitted in following way:

- Scanned originals certified, stamped, signed by an authorized person of the company, to the following e-mail address: ponudi@esm-prodazba.mk
- Electronically signed offers by an authorized person of the company, to the following e-mail address: ponudi@esm-prodazba.mk
- In case of acceptance of the offer, the selected bidder is obliged to submit the offer and accompanying documentation in original within 1 (one) day from the date of the received notice of accepted offer.
